# Medical Faculty Mannheim of Heidelberg University – MSc Application Form

## Legal basis for data handling

Individual data shall be collected, stored and processed in performance of the lawful functions of the university (including its faculties, central bodies, institutes and secretariats) pursuant to paragraphs 2, 32 to 38, and 58 to 62 of the University Act of the State of Baden-Württemberg (Landeshochschulgesetz, hereinafter LHG) of January 1<sup>st</sup>, 2005 (GBl. No. 1, p1 et seq.) and pursuant to the Data Protection Act of the State of Baden-Württemberg (Landesdatenschutzgesetz, hereinafter LDSG). The regulation issued by the Ministry of Science pursuant to paragraph 12 of the LHG on the collection and processing of personal data of January 1<sup>st</sup>, 2005 (GBl. No.1, p1 et seq.) permits such data to be transmitted to third parties, in particular to other universities, statutory health insurance agencies, child benefit funds of government employment offices, public relief associations and the salary office of public employers, if the requirements in paragraphs 13 to 16 of the LDSG have been satisfied.

**Please note the following:** All documents must be uploaded to **heiCO** at the latest on **March 15<sup>th</sup>**. Only complete applications with all required documents will be processed.

## One of the following tests needs to be provided to prove your English proficiency:

- **IELTS – Academic:** Minimum overall score of 6.5, with a minimum of 6.0 in each section
- **TOEFL iBT (Internet-Based Test):** Minimum overall score of 92, with a minimum of 21 in each section
- **TOEFL CBT (Computer-Based Test):** Minimum overall score of 237, with a minimum of 21 in each section
- **TOEFL PBT (Paper-Based Test):** Minimum overall score of 580, with a minimum of 55 in each section
- **Cambridge English Certificates:** *Certificate of Advanced English (CAE) / Certificate of Proficiency in English (CPE)*

## Please keep the following in mind:

- IELTS and TOEFL scores must be **less than two years old** (this rule does not apply to CAE and CPE certificates).
- Only the above-mentioned test modalities will be accepted (IELTS – General Training will **NOT** be accepted, and neither will be institutional TOEFL tests).
- You may still apply and be considered even if you have not yet taken an English proficiency test, or while your test score is still unknown, insufficient or too old. In this case, final admission will depend on passing one of the above-mentioned tests **before the start of the programme**. If you are in such a situation, please inform the admissions office of the date on which you plan to take the test.

## Submission of test results:

- **IELTS:** Please provide a copy of your score report, we will verify the score online.
- **TOEFL:** Please provide a copy of your score report, and submit a request with ETS to allow us to access your test results in the ETS online database (institution code 6446).
- **CAE/CPE:** Initially, a copy of the score report can be sent. If you are admitted to the programme, we will require a certified copy of the certificate.

**Exemptions:** All applicants must provide proof of proficiency in English with their applications. Only applicants who meet either of the following requirements are exempt from doing so:

- **Native English speakers** who have completed their **secondary education** in any of the following countries:  
*Australia, Canada, Ireland, New Zealand, UK, USA*
- Applicants who have completed their **bachelor education** in any of the following countries:  
*Australia, Canada, Ireland, New Zealand, UK, USA*

Applicants from other English-speaking countries are **NOT EXEMPT** from providing an English proficiency certificate. A certificate stating that English is the main language of instruction at the University is not sufficient, unless it is from one of the above-mentioned countries.
